1. Fees for Hauling, Mast Step, Storing, and Launch are due in advance, prior to haul out.
2. OYC will haul boats on any week-end in October and launch on any week-end in May. Additional times may be available by appointment. Owners are expected to be present and assist. Owners are expected to schedule in advance and be derigged and ready the day you are requesting by contacting Andy Sharp 716-957-4934 or Paul Elter 716-799-2162
3. BOATS MUST BE LAUNCHED BY MAY 31<sup>st</sup> AND HAULED BY OCTOBER 31<sup>st</sup>. Olcott Yacht Club only provides winter storage. OYC DOES NOT PROVIDE STORAGE BETWEEN JUNE 1 AND SEPTEMBER 1. Penalty for Summer Storage is \$20 per day. If boat is abandoned, owner agrees to allow OYC to remove the boat at owner expense.
4. The owner agrees that their boat shall be hauled, stored and launched at their own risk and will hold Olcott Yacht Club, Inc. and it's Haulout Committee harmless from any and all claims arising out of said haul out, storage or launch of the boat and the work thereon by themselves or any other person. In addition, the owner releases Olcott Yacht Club, Inc. from any damages which may be sustained to himself or the vessel while being hauled, stored or launched regardless of who shall have caused such damage. The owner acknowledges that their boat is fully insured for any damages the vessel may cause and that said policy will remain in effect until the vessel is removed from OYC property.
5. No work may be performed by outside tradesmen without the prior approval of the Haulout Committee. A charge may be assessed for using OYC facilities.
6. Only sailboats with suitable cradles may be stored with masts up; sailboats with jackstands must store with the mast down. Jackstands must have suitable base, plywood pad and proper connecting chains.
7. GOOD HOUSEKEEPING IS EXPECTED. SHRINKWRAP IS TO GO HOME IN THE SPRING. PLEASE DO NOT LEAVE YOUR MESS FOR OTHERS TO PICK UP.
